

2010 CAMPAIGN FINANCE REPORTS FILING SCHEDULE

FEBRUARY 2, 2010 – YEAR END SUPPLEMENTAL (ALL CANDIDATES)

- Last day for a candidate that **has appointed a political treasurer, for the 2010 elections, before January 13, 2010** to file a year-end supplemental campaign financial disclosure statement. In addition, any candidate with an old campaign account still open must file the year-end supplemental report.
- This report will cover one of the following periods:
 - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through January 15, 2010.
 - if a mid-year supplemental report was filed covering the period through June 30, 2009, the report will cover the period from July 1, 2009 through January 15, 2010.

2010 LOCAL ELECTION CANDIDATES (MAY PRIMARY AND AUGUST GENERAL ELECTION)

County Mayor, County Commission, County Trustee, Sheriff, Circuit Court Clerk, County Clerk, Register of Deeds, Commissioner of Highways, County Attorney, Constable

APRIL 12, 2010 – 1st QUARTER

- Last day for a candidate to file a 1st Quarter campaign financial disclosure report.
- This report will cover the following period:
 - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through March 31, 2010.
 - if a year-end supplemental report was filed covering the period through January 15, 2010, the report will cover the period from January 16, 2010 through March 31, 2010.

APRIL 27, 2010 – PRE-PRIMARY (MAY 4 PRIMARY ELECTION)

- Last day for a candidate participating in the May 4 primary election to file a pre-primary campaign financial disclosure statement.
- The report will cover the following period:
 - April 1, 2010 through April 24, 2010
 - Independent candidates are also required to file this Pre-Primary report.

MAY 4, 2010 – ELECTION DAY

JULY 12, 2010 – 2nd QUARTER

- Last day for a candidate to file a 2nd Quarter campaign financial disclosure report.
- The report will cover the following period:
 - April 25, 2010 through June 30, 2010

JULY 29, 2010 – PRE-GENERAL (AUGUST 5 GENERAL ELECTION)

- Last day for a candidate participating in the August 5 general election to file a pre-general campaign financial disclosure statement.
- The report will cover the following period:
 - July 1, 2010 through July 26, 2010

AUGUST 5, 2010 – ELECTION DAY

OCTOBER 11, 2010 – 3rd QUARTER

- Last day for a candidate to file a 3rd Quarter campaign financial disclosure statement.
- The report will cover one of the following periods:
 - if the candidate won in the May 4 primary election, the report will cover the period from July 27, 2010 through September 30, 2010.
 - if the candidate lost in the May 4 primary election, the report will cover the period from July 1, 2010 through September 30, 2010.

JANUARY 25, 2011 – 4th QUARTER

- Last day for a candidate with an open campaign account to file a 4th quarter campaign financial disclosure statement.
- The report will cover the following period:
 - October 1, 2010 through January 15, 2011

LOCAL ELECTIONS (AUGUST GENERAL ONLY)

County School Board

APRIL 12, 2010 – 1st QUARTER

- Last day for a candidate to file a 1st Quarter campaign financial disclosure report.
- This report will cover the following period:
 - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through March 31, 2010.
 - if a year-end supplemental report was filed covering the period through January 15, 2010, the report will cover the period from January 16, 2010 through March 31, 2010.

JULY 12, 2010 – 2nd QUARTER

- Last day for a candidate to file a 2nd Quarter campaign financial disclosure report.
- The report will cover the following period:
 - April 1, 2010 through June 30, 2010

JULY 29, 2010 – PRE-GENERAL (AUGUST 5 GENERAL ELECTION)

- Last day for a candidate participating in the August 5 general election to file a pre-general campaign financial disclosure statement.

 - if the candidate lost in the May 4 primary election, the report will cover the period from July 1, 2010 through September 30, 2010.

JANUARY 25, 2011 – 4th QUARTER

- Last day for a candidate with an open campaign account to file a 4th quarter campaign financial disclosure statement.
- The report will cover the following period:
 - October 1, 2010 through January 15, 2011

2010 STATE ELECTION CANDIDATES (AUGUST PRIMARY AND NOVEMBER GENERAL)

U.S. House of Representatives, Governor, Tennessee House of Representatives

APRIL 12, 2010 – 1st QUARTER

- Last day for a candidate to file a 1st Quarter campaign financial disclosure report.
- This report will cover the following period:
 - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through March 31, 2010.
 - if a year-end supplemental report was filed covering the period through January 15, 2010, the report will cover the period from January 16, 2010 through March 31, 2010.

JULY 12, 2010 – 2nd QUARTER

- Last day for a candidate to file a 2nd Quarter campaign financial disclosure report.
- The report will cover the following period:
 - April 1, 2010 through June 30, 2010

JULY 29, 2010 – PRE-PRIMARY (AUGUST 5 PRIMARY)

- Last day for a state candidate participating in the August 5 primary election to file a pre-primary campaign financial disclosure statement.
- The report will cover the following period:
 - July 1, 2010 through July 26, 2010
 - Independent candidates are also required to file this Pre-Primary report.

AUGUST 5, 2010 – ELECTION DAY**OCTOBER 11, 2010 – 3rd QUARTER**

- Last day for a candidate to file a 3rd Quarter campaign financial disclosure statement.
- The report will cover one of the following periods:
 - if the candidate won in the May 4 primary election, the report will cover the period from July 27, 2010 through September 30, 2010.
 - if the candidate lost in the May 4 primary election, the report will cover the period from July 1, 2010 through September 30, 2010.

OCTOBER 11, 2010 – PRE-GENERAL (NOVEMBER 2 GENERAL ELECTION)

- Last day for a state candidate participating in the November 2 general election to file a pre-general campaign financial disclosure statement.
- This report will cover the following period:
 - October 1, 2010 through October 23, 2010

NOVEMBER 2, 2010 – ELECTION DAY**JANUARY 25, 2011 – 4th QUARTER**

- Last day for a candidate with an open campaign account to file a 4th quarter campaign financial disclosure statement.
- The report will cover the following period:
 - October 24, 2010 through January 15, 2011
