

2012 CAMPAIGN FINANCE REPORTS FILING SCHEDULE

JANUARY 31, 2012 – YEAR END SUPPLEMENTAL (ALL CANDIDATES)

- Last day for a candidate that has appointed a political treasurer, for the 2012 elections, before January 15, 2012 to file a year-end supplemental campaign financial disclosure statement. In addition, any candidate with an old campaign account still open must file the year-end supplemental report.
- This report will cover one of the following periods:
 - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through January 15, 2012.
 - if a mid-year supplemental report was filed covering the period through June 30, 2011, the report will cover the period from July 1, 2011 through January 15, 2012.

 - if the candidate lost in the March 6 primary election and has an open campaign account, the report will cover the period from July 1, 2012 through September 30, 2012.

JANUARY 25, 2012 – 4th QUARTER

- Last day for a candidate with an open campaign account to file a 4th quarter campaign financial disclosure statement.
- The report will cover the following period:
 - October 1, 2012 through January 15, 2013
