#### JANUARY 31, 2024 - YEAR END SUPPLEMENTAL

- If you are a candidate on the ballot in 2024 and do not have a campaign account from a previous election and you appointed a political treasurer before January 15, 2024 you are required to file this financial disclosure statement.
- Candidates with a prior election campaign account still open must file the year-end supplemental report.
- This report will cover one of the following periods:
  - o if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through January 15, 2024.
  - o if a mid-year supplemental report was filed covering the period through June 30, 2023, the report will cover the period from July 1, 2023 through January 15, 2024.

  - o February 25, 2024 through March 31, 2024

#### **JULY 10, 2024 - 2<sup>nd</sup> QUARTER**

- The report will cover the following period:
  - o April 1, 2024 through June 30, 2024

#### JULY 25, 2024 - PRE-GENERAL (AUGUST 3 GENERAL ELECTION)

- The report will cover the following period:
  - July 1, 2024 through July 22, 2024
  - This report is only required for candidates participating in the August 1, 2024 General Election.

  - o July 23, 2024 through September 30, 2024.
