

# 2026 CAMPAIGN FINANCE REPORTS FILING SCHEDULE

## **February 2, 2026 – YEAR END SUPPLEMENTAL**

- If you are a candidate on the ballot in 2026 and do not have a campaign account from a previous election and you **appointed a political treasurer before January 15, 2026** you are required to file this financial disclosure statement.
- Candidates with a prior election campaign account still open must file the year-end supplemental report.
- This report will cover one of the following periods:
  - if this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through January 15, 2026.
  - if a mid-year supplemental report was filed covering the period through June 30, 2025, the report will cover the period from July 1, 2025 through January 15, 2026.

## **APRIL 10, 2026 – 1<sup>st</sup> QUARTER**

- This report will cover the following period:
  - If you filed Year End Supplemental Report: January 16, 2026 through March 31, 2026
  - If this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through March 31, 2026.

## **APRIL 28, 2026 – PRE-PRIMARY (MAY 5, 2026 PRIMARY CANDIDATES ONLY)**

- The report will cover the following period:
  - January 16, 2026 through April 25, 2026
  - If this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through April 25, 2026.

## **JULY 10, 2026 – 2<sup>nd</sup> QUARTER**

- The report will cover the following period:
  - If you filed a Pre-Primary Report: April 26, 2026 through June 30, 2026
  - If you did not file a Pre-Primary Report: April 1, 2026 through June 30, 2026
  - If this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through June 30, 2026.

## **JULY 30, 2026 – PRE-PRIMARY (BRISTOL SCHOOL BOARD CANDIDATES) PRE-GENERAL (AUGUST 6 GENERAL ELECTION CANDIDATES ONLY)**

- The report will cover the following period:
  - July 1, 2026 through July 27, 2026
  - This report is only required for candidates participating in the August 6, 2026 General Election.
  - If this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through July 27, 2026.

## **OCTOBER 13, 2026 – 3<sup>rd</sup> QUARTER**

- The report will cover the following period:
  - If you filed a Pre-General Report: July 28, 2026 through September 30, 2026
  - If you did not file a Pre-General Report: July 1, 2026 through September 30, 2026
  - If this is your first report, it will begin with the date of the first contribution or first expenditure, whichever occurred earlier, and extend through September 30, 2026.

## **OCTOBER 27, 2026 – PRE-GENERAL (BRISTOL COUNCIL AND BLUFF CITY BMA CANDIDATES)**

- The report will cover the following period:
  - October 1, 2026 through October 24, 2026
  - If you did not file a Pre-General Report: July 1, 2026 through September 30, 2026

## **JANUARY 25, 2027 – 4<sup>th</sup> QUARTER**

- The report will cover the following period:
  - October 1, 2026 through January 15, 2027
