- BOTH INDEPENDENT AND PARTISAN CANDIDATES HAVE THE SAME QUALIFYING DEADLINE AS LISTED FOR EACH OFFICE
- OFFICES AND REFERENDUM QUESTIONS ARE SUBJECT TO BE ADDED TO THE BALLOT OF ANY ELECTION
- JANUARY 1 IS THE FIRST DATE THAT ACTIVE DUTY MILITARY AND CITIZENS OVERSEAS MAY REQUEST AN ABSENTEE BALLOT
- EARLY VOTING HOURS AND LOCATIONS ARE DIFFERENT FOR EACH ELECTION WITHIN THE REQUIRED TIMEFRAME
- EACH COUNTY POLITICAL PARTY INDEPENDENTLY DETERMINES THE COUNTY OFFICES FOR WHICH A PRIMARY IS HELD
- STATE LAW REQUIRES MUNICIPAL ELECTIONS AND SCHOOL BOARD ELECTIONS TO BE NON-PARTISAN
- VACANCY ELECTIONS ARE TO FILL THE REMAINDER OF AN UNEXPIRED TERM
